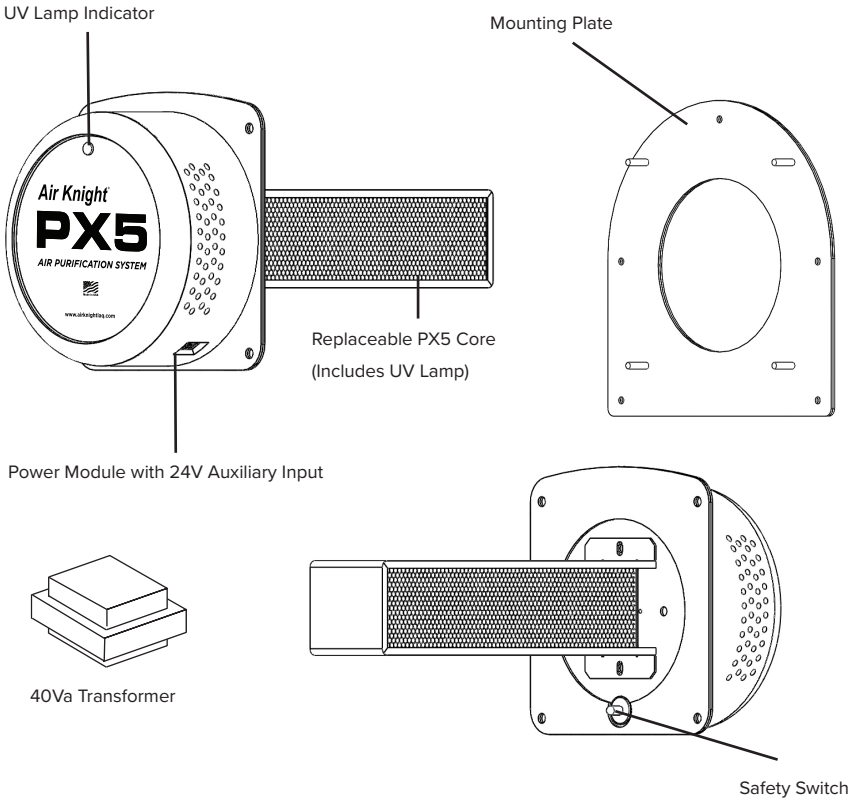

INSTALLATION NOTES

1. Unit should be installed after the air handler or furnace in the HVAC system, prior to any branch duct takeoffs.
2. The ductwork around the installation area should be clean and dry to insure proper adhesion of the gasket materials and any tape used.
3. An approximate 4" opening will need to be cut into the existing ductwork to install unit properly.

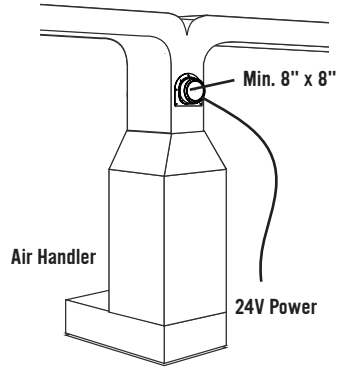


Fig. 1 HVAC system.

AIRFLOW ORIENTATION

Be sure to orient the unit for proper airflow through the PX5 core in either horizontal or vertical air flow systems. Air should be able to freely flow through PX5 core as shown.

Remove air flow tag BEFORE installation.

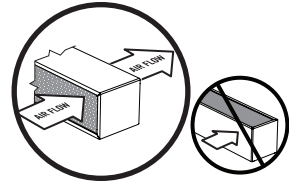


Fig. 2 Orient core in proper airflow direction.

METAL DUCTWORK INSTALLATION

- Locate a suitable area of the duct for installation. Minimum 8" area. If needed, cut away insulation to expose metal duct.
- Mark location for 4" opening using the included mounting plate as a template.
- Cut opening for the device.
- Remove the backing from the mounting plate gasket, center mounting plate over opening, and press onto the duct. The adhesive gasket will hold the mounting plate in place.
- Secure the mounting plate using self-tapping screws.
- Insert device into opening and secure with knurled nuts.

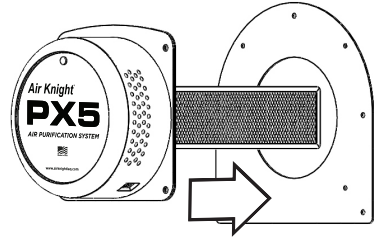


Fig. 3 Cut opening in duct, attach mounting plate, and install device.

Note: Be sure airflow will pass in the proper direction as indicated by the arrow on the top of the core. (See fig.3)
- Connect to proper power and test operation. The operation indicator light on the face of the device should be on.

FIBERGLASS DUCTWORK INSTALLATION

For fiberglass ductwork installations, follow metal ductwork installation steps, but use 3" toggle bolts to attach mounting plate.

MAINTENANCE/UV LAMP INDICATOR

For optimal performance, replace the PX5 core w/UV bulb (5" core - #TT-AKCELL-5, 9" core - #TT-AKCELL-9) every 4 years. Replace the UV bulb (5" bulb - #TT-AK5-BULB, 9" bulb - #TT-AK9-BULB) every 2 years. Replace even if the UV bulb appears to be operating normally.



The LED on the face of the device indicates proper UV lamp operation. If the indicator does not glow after verifying the unit has power, proceed to replacing the UV lamp.

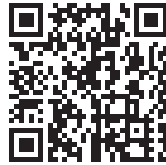
CORE INSPECTION

The ionization system should be inspected annually. Carefully clean the honeycomb with compressed air (20 PSI MAX) and ensure there are no flow obstructions within the honeycomb. Do not use any solvents or cleaners on the unit during service.

CHANGING THE CORE OR UV-C LAMP

- Disconnect the device from power.
- Removed the knurled nuts securing the device and remove the device from the core.
- Remove the screws securing the core.
- Remove the core from the device and dispose of properly. Note: If only changing the UV-C lamp, detach lamp from device and dispose of properly.
- Secure the new core or new UV-C lamp to the device. **DO NOT TOUCH clear quartz portion of bulb with bare hands or any contaminated material.**
- Reverse the previous steps to return the device to operation.

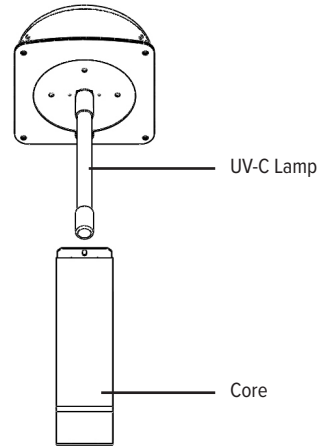


Fig. 4 Replace the core every 4 years and replace the UV bulb every 2 years.
